Hankook 'Great Hit 2011' Mail-in Rebate Promotion

 - \$80 Rebate following the retail purchase of four (4) Hankook Ventus V12 evo (K110)
 - \$50 Rebate following the retail purchase of four (4) Hankook Optimo (H426)

The sales invoice must include the Name of the Retailer where the qualifying tires were purchased, Date of Purchase, Description of Product(s) Purchased and Method of Payment. Any rebate application(s) that do not have all of the required information included will not be processed.**
- 3. To be eligible for the promotion consumers must reside within the United States or Puerto Rico and must purchase their tires from an authorized Hankook dealer located within the United States or Puerto Rico. This offer is not valid where restricted, taxed, or prohibited by law.**
